GENERAL NARRATIVE DESCRIPTION OF THE POSITION

The Instructor in Science will be responsible for teaching courses within the Physical and Biological Sciences Department. These may include anatomy and physiology, microbiology, biology, physical science, and chemistry and other science courses as needed. A master's degree and 18 hours in science discipline is required. Additionally, it is preferable that the candidate has college teaching experience and experience in incorporating and utilizing technology within the curriculum and classroom.

The administration retains the right to change the responsibilities at any time.

RESPONSIBILITIES

The Science Instructor will:

1. discharge effectively and efficiently the duties and responsibilities as defined in the Master Contract;
2. teach courses within the Science Department including courses in anatomy and physiology, microbiology, biology, physical science, chemistry and other courses;
3. work with the division and department in the development of assessment and competencies for courses in the department and division;
4. work with the division and department in the development and approval of programs;
5. work with the division and department in the program review process;
6. work with the division and department in the student outcome assessment process;

7. assist in the mentoring of faculty both on and off-campus;
8. work with the division and department on follow-up of graduates;
9. participate in division, department, and faculty activities including working with advisory committees for AAS programs;
10. work with and coordinate laboratory activities with other science instructors;
11. prepare syllabi for all courses taught following the format prescribed by the State of Kansas and have those syllabi on file in the Vice President for Academic Affairs' office;
12. work with the department chair and the division dean on the preparation of the class schedule each semester;
13. provide information to the Academic Affairs' office for federal, state, and internal reports;
14. work with the administrative assistant for the division, department chair and the division dean on the preparation of the budget and correctly prepare purchase requisitions;
15. assist in the development of promotional materials for the Physical and Biological Sciences department and the division, and assist in the recruitment of students;
16. incorporate technology into the curriculum;
17. assist in the development and delivery of online courses in physical and biological sciences;
18. teach classes as needed in the evening, on the Concordia Campus, on the Geary County Campus, outreach sites, online, and in shortened or flexible formats;
19. work with business and industry to develop relationships and support for physical and biological sciences;
20. emphasize working in the global society within the curriculum;
21. work with other disciplines to develop interdisciplinary courses and/or programs;
22. attend workshops and seminars, if necessary (valid driver's license required and overnight travel may be required);
23. assist in delivering educational programs and other services to companies and organizations;
24. work with diverse populations;

25. attend and participate in commencement exercises in academic attire; and
26. perform other duties as assigned by the Vice President for Academic Affairs, the Division Dean, or the Department Chair.
