An eligible student many receive a full Federal Pell Grant for Summer 2022 even if the student received a full Federal Pell Grant during the Fall and Spring semesters. Additional Federal Pell Grant (up to 150% of their Federal Pell Grant Scheduled award) may be available for the Summer 2022 semester.

To be eligible, a student must:

- Have an official ISIR on file for the 2021-2022 academic year.
- Have completed all verification required, if applicable.
- Be enrolled in at least **6** credit hours for the summer semester in classes that are needed for the student's degree or certificate program.
- Be in good academic standing, i.e. making Satisfactory Academic Progress. (Ex: Maintaining a 67% Completion Rate & 2.0 GPA)
- Have a Pell Lifetime Eligibility Used (LEU) percentage of less than 600%.

The amount of Federal Pell Grant is based upon the student's Expected Family Contribution (EFC) as determined by the student's FAFSA filing, the student's Cost of Attendance, and the student's FA Eligible enrolled hours.

The student's eligibility for Additional or Year Round Pell Grant will be determined by the Financial Aid Office and posted to the Student's Account approximately one week prior to the beginning of the summer semester.

Students who have <u>not</u> received full Federal Pell Grant for the Fall and Spring semesters may have remaining Federal Pell Grant from their original Scheduled Award.

NOTE: All Federal Pell Grant Disbursements continue to count toward lifetime limits of 600%. All other eligibility requirements will apply.

Different types of Federal Financial Aid require that the student be enrolled in a specific number of hours before being eligible to receive that award. Students must be enrolled in at least half-time status to receive loans at any time and will also need to complete the **Summer Federal Direct Loan Request Form** to request a loan.

Students are NOT eligible to receive Financial Aid from two different schools for the same enrollment period. If you intend to enroll at CCCC and at another institution, please contact the Financial Aid Office.
